Most Rev. Peter Remigius, S/o. Peter, residing at Bishops house, Asaripallam Road, Nagercoil-1, Agastewaram Taluk, Kanyakumari District, herein after called the Managing Trustee of the trust who is the authour and founder of the trust.

3) The objectives of the trust shall be:-

The trust is established for charitable, medical, educational and social purposes for the benefit of the needy irrespective of caste, creed, sex or status.

To establish and administer educational institutions, Hospitals, ashrams, retreat houses, old age homes, welfare centers, training centers, industrial training centers.

To start and promote all round education in all or any branches of the arts, science and technology, medicine, para-medicine, commerce, law and law managements.

To promote Physical, Moral, and Social development of persons, Sports and sports related activities for any level of age by establishing and running schools, colleges and institutions.

To establish, set up, conduct, maintain, run, subsidise, aid, sponsor hospitals, dispensaries, clinics, orphanages and other medical institutions for the welfare of the General Puplic.

To establish, manage, run educational institutions of both Technical, and Non-Technical nature such as Engineering Colleges, Medical Colleges, Dental Colleges, Pharmacy Colleges, Arts and Science Colleges, Community Colleges, Colleges of Nursing, Colleges of Education, in collaboration with the Catholic diocese, the State and Central Government, for the younger generation to seek higher studies after their passing necessary qualifying examination in the field of Technical, Medical, and Academic Studies.

To initiate , establish, support, administer and promote the advancement of educational activities in all its branches, particularly schools including Nursery, Elementary, Middle, Secondary, and Higher Secondary Schools, Teachers Training schools, Industrial and Agricultural institutions, Polytechnics, Industrial training institutes, Institute of Management, Social Service and Youth centre, and all type of Women and Children institutions, both technical and non technical, etc.

To establish and maintain, Computer and Technical Institutions, Software Development centers, Vocational training and other allied Institutions.

To develop distance mode education centers for UG, PG, Research courses and Computer courses.

To provide accommodation, hostel facilities, equipments and other necessities to the educational institutions.

To establish research laboratories and to promote research activities to allocate the educational needs of the society and to establish research centres.

To establish, provide, maintain and promote libraries and reading rooms.

To manage and regulate the affairs of Educational Institutions.

To establish educational institutions in global level.

To establish Employment centers.

To start hospital and Homes for destitute and aged people.

To give free education and free medicine to the poor people

To receive and collect subscriptions and donations of any kind or acquire in lawful ways, and means, and spend the same in fulfillment of all or any of the aims and objects of the Trust.

To establish, organize, conduct and take over such institutions as are necessary to promote the cause of education and its advancement.

To establish and maintain career counseling and training centers and development agencies.

To extend scholarships for education to deserving students.

To promote adult education.

To establish, conduct, maintain, subsidise, aid, sponsor or to provide, facilities for orphans, mentally or physically or psychologically challenged person, alcoholics and families affected by alcoholism, unemployment or any other similar social problems.

4) Board of Trustees:-

The board of trustees shall consist of the founder cum managing trustee and other trustees, who shall be nominated by the Managing Trustee. At present the following persons are nominated to the board.

1. Fr.Sahaya Dhas, S/o.Pathrose aged 40 Vice president, Now residing at Church of our lady of Nativity Mulagumoodu.
2. Fr.Peter, S/o.Mr.Maria Kon, aged 62 Treasurer, Now residing at Church of the Most Holy Trinity, Thiruthuvapuram.
3. Fr.Dominic Kadatcha Dhas, S/o.Mr.Moses Motcha Dhas aged 45, Secretary, Now residing at St.Sebastian Church of the pallavilai, Nagercoil-3.
4. Fr.Maria William, S/o.Mr.Maria Soosai aged 50 Member, now residing at church of the our lady of Nativity, Mulagumoodu.
5. Fr.Jesu Rethinam, S/o.Mr.Thanislus aged 63 member, now residing at St.Sebastian church, Madathattuvilai, Villukury.
6. Fr.Benny, S/o.Mr.Lucas, aged 36, member now residing at church of the St.Antony, Mullanginavilai.

5) Administration of the trust:-

- A. The managing trustee shall be, at present, the bishop of Kottar.
- B. The administration of all the affairs of the trust shall be with the Managing Trustee.
- C. The number of Trustees shall be not less than 5 and not more than 11
- D. The members of the board of Trustees shall hold office as per the will and pleasure of the Managing Trustee.
- E. In case of any vacancy arising in office of the trustees by reason of death, resignation or other valid reasons, the same shall be filled in by nomination by the Managing Trustee.

- F. At the time of vacancy of any office the charge may be entrusted to another trustee by the Managing Trustee till the vacancy is filled by nomination.
- G. If any one of the Trustees decides to withdraw from the trust, he or she shall do voluntarily and without any claim what so ever over the assets of the trust.
- H. The managing trustee shall appoint one of the trustees to the post of secretary and another to the post of financial trustee. They hold office for a Period prescribed by the Managing Trustee and the duties and functions of the office bearers shall be prescribed by the Managing Trustee in consultations with the Board of Trustees.
- I. Special committees may be constituted of experts, advisers and by people for specific purpose and the powers and duties of such special committees shall be prescribed by the Board of Trustees.
- J. If any of the Trustees act against the objectives of the trust, the managing trustee or the board can take disciplinary action against him/her even to the point of dismissal.

**6) Financial year of the Trust:-**

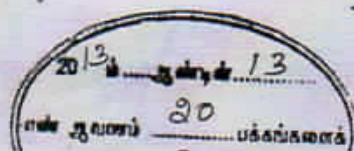
The financial year of the trust shall be from 1<sup>st</sup> of April to 31<sup>st</sup> of March every year. All the accounts of the trust shall be closed for that period and statement of receipt and expenditure and balance sheet shall be prepared and audited by a qualified chartered accountant and signed by the Managing Trustee and other trustees.

**7) Properties vested in the Trust:-**

This Trust has powers:-

To acquire on lease, or otherwise sell, mortgage, lease out or transfer in any other manner (movable or immovable),

construct buildings and effect other improvements for the purpose of the trust.

To acquire, improve immovable and movable properties and take on lease or hire and apply both the income and capital thereof and the proceeds of the sale or mortgage thereof for or towards the objectives of the trust.

To purchase or acquire or hire any immovable or movable properties for the trust on such terms and / or such value or consideration and / or for such period as the trustees may think fit.

To sell or to convert or change any or all portions of the movable or immovable properties of the trust, on such terms and / or at such value or consideration and or for such period as the trustees may think fit.

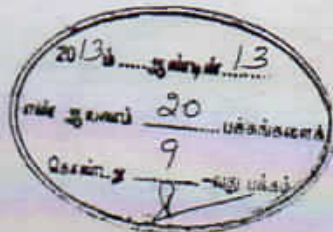
To let any portion of any immovable properties forming part of the trust fund as such rent and for such period and on terms and condition as the trustees may think fit.

To borrow or raise money with security or pledge or mortgage or otherwise charge any of the properties belonging to the trust for carrying on the objects and the purpose of the trust.

**Power to frame rules:-**

It is decided or understood that the trustees shall have power to frame rules and / or bye law, and to alter, vary, amend, delete, and also add rules and / or by laws for the conduct and the management of the trust or the trust fund for carrying out the trust. Such rules or by laws framed, amended, altered, varied, deleted or substituted

shall have the same force as if they have been incorporated in the original trust hereby created but not repugnant to the nature and objects of the Trust with the consent and the approval of the Managing Trustee.

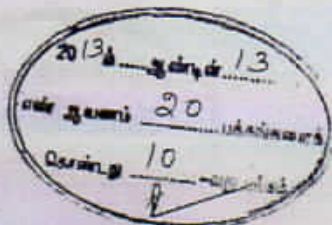
The Funds of the Trust:-

1. The initial fund of the trust shall be a sum of Rs.10,000/- and it has no other funds or properties while on registration of this deed.
2. Further donations and gifts made by the trustees and other persons or organization shall be included in the funds of the trust in future.
3. Aids, grants and helps from Government and other institutions and organizations shall be included in the funds of the trust in further.
4. Fee collected from students in the future from institutions run under the trust will also be included in the funds of the trust in future.
5. Interest on investments and income from immovable properties which will be acquired in future also be included in the funds of the trust in future.
6. All the funds of the trust shall be solely and entirely used for the objects of the trust.
7. The trust has at present no immovable and movable property.

This Trust has powers-

To raise funds, and to receive and use any gifts, donation or foundation in cash or kind, other movable or immovable properties of all descriptions and to undertake, and to carry out

administration of or management of the said Trust and / or any other trust that may be handed over to it, or management and control of any institutions, establishment or organization that may have similar aims of objectives and purpose.

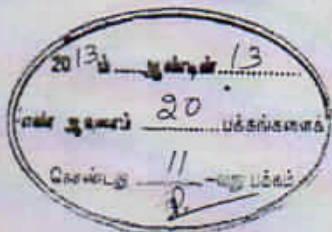
To open and maintain banking accounts in the name of the trust as the trustees may decide and to make the said banking account (s) operatable by such one or more of them as they may decide from time to time.

To invest the not immediately required money for the purpose of the trust in term deposits with bank or in government securities on such terms and may seem expedient to the trust.

Role of the managing trustee:-

1. The managing trustee has an overall responsibility over all activities of the trust. He shall keep himself well informed and acquainted, with the activities being planned and implemented by the trust.
2. The managing trustee has the prerogative of taking decisions by himself on any matter related to the administration of the trust. The other trustees only have an advisory role.
3. He shall be competent to make or execute documents on behalf or representing the trust.
4. He shall be competent to sign all project proposals and progress reports to the submitted to the various funding agencies, government etc.
5. The Managing Trustee himself or jointly shall operate all the bank accounts relating to the trust.
6. He shall be authorized to incur the expenditures to fulfill the aims of the trust or those that have been sanctioned by the board of trustees.

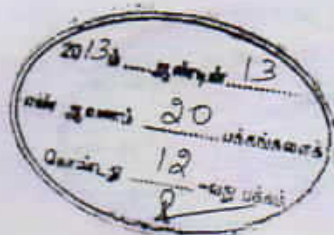


7. The managing trustee shall be competent to perform his powers for the furtherance of the objectives of the trust.
8. The managing trustee shall be responsible for the execution and implementation of all activities which fall within the purview of the objectives of the trust.
9. The trust sues or be sued in the name of the managing trustee.
10. The managing trustee is empowered to recruit or employ professional or technical experts, advisers, consultants or workers for providing know-how and information to further the objectives of the trust and to pay them such honorarium or fees as may be thought expedient.
11. The managing trustee himself or in consultation with the board of trustees may remove the secretary and financial trustee for breach of trust.
12. The Managing Trustee, if he resigns or retires or dies the Diocesan Administrator will act as Managing Trustee. He shall hold office till a new bishop is appointed.
13. In consultation with the Managing Trustee or as decided by the Board of Trustees, the secretary shall convene the meetings of the board of Trustees and of the annual board meeting and submit the reports and maintain relevant records pertaining to the same.
14. The Managing Trustee or a person deputed by him shall maintain all the registers and files of the trust as required under the existing laws of the country.

**Finance trustee:-**

1. The financial trustee with the managing trustee and secretary shall jointly operate all the Bank accounts relating to the trust.

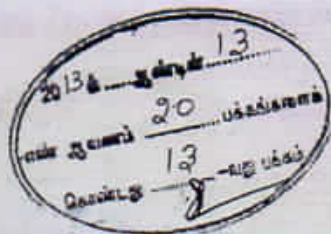

2. The financial trustee shall release the funds for the schemes or project or programmes sanctioned by the managing trustee or board of trustees with the concurrence of the secretary.
3. The financial trustee shall keep the books of accounts of the trust as required by the existing laws of the country.
4. The financial trustee shall place before the annual meeting at the end of each financial year a statement showing the details of financial transactions and the balance sheet.
5. The financial trustee shall produce the monthly receipts and disbursement statement before the meeting of the board of trustees.
6. The financial trustee shall, in consultation with the managing trustee and the secretary, prepares the annual budget and present it to the trustees meetings at the beginning of the year.
7. He/She shall be liable to be removed from his / her post as financial trustee by the Managing Trustee himself or in consultation with the board of trustees for the breach of trust reposed on him/her.
8. The financial trustee shall get the account of the trust audited by qualified auditors or auditors appointed by the board of trustees at the end of the year.

Secretary:-

1. The secretary will be the executive director of the programmes and project for the furtherance of the aims and objects of the trust.
2. The secretary shall co-operate with the managing trustee and render all help to him in all activities of the trust.
3. The secretary shall convene all the meetings of the board of the trustees as directed by the Managing Trustee and record the



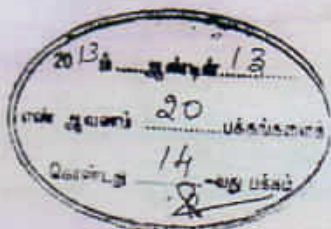

proceedings of the meetings in the minutes book and obtain the signature of the board of the trustees.

4. The secretary in consultation with the Managing Trustee will submit the project proposals within the prescribed relevant time schedule;
5. He will operate the Bank accounts of the trust jointly with the Managing Trustee and the financial trustee.
6. He shall submit to the board of trustees the report of the implementation of the programmes and projects.
7. He shall be the convener of the programme committee, constituted by the Managing Trustee to plan and propose programmes or projects, to implement, monitor and evaluate them, with the approval of the Managing Trustee or Board or Trustees.

**Functions and powers of the board of trustees:-**

1. Carrying out the objects of the trust.
2. Verifying all accounts of receipt and expenditure and preparing the budgets of the trust.
3. Supervising and managing the properties of the trust.
4. Purchasing, acquiring and sale of properties of the trust.
5. All the documents executed by or in favor of the trust shall be represented by the managing trustee or in his absence, by the secretary.
6. Carrying on all activities and affairs for obtaining the goal according to the objects of the trust.
7. The Board of trustees shall meet once in 3 months. Special meetings of the board may be held whenever necessary.
8. The quorum for the meeting shall be 2/3
9. The Managing Trustee or in his absence, the member nominated by the Managing Trustee will preside over the meetings.

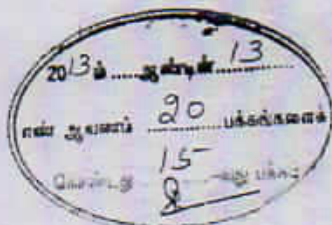

10. The secretary shall record the names of the members present for the meetings and also report the month's achievements and any proposal or project for the succeeding month.
11. The office-bearers shall discharge their functions in conformity with the provisions contained in this trust deed and the rules and regulations of the government.
12. The managing affairs of the trust shall be entrusted to and vested in the Board of Trustees, who shall propose and execute detailed plans and programmes to carry on its administration and management.
13. The managing trustee shall receive grants and contributions and act as custodian of the same for promotion of the object of the trust.
14. The board may, with the concurrence of the managing trustee, appoint or employ for the different centers or wings temporarily or permanently any person or persons who may be required for the purpose of the organization and to pay the wages, salaries or remuneration and to allow them suitable perquisites and benefits and other facilities as may be decided upon from time to time.
15. The trust shall maintain a register containing the names, addresses and occupations of its trustees.
16. The trust is empowered to purchase, accept as a gift or otherwise acquire and own or take on lease or hire temporarily or permanently any movable or immovable properties necessary or convenient for the furtherance of the objects or the trust and to deal with the same in any manner whatsoever and sell, assign, mortgage, lease, exchange or otherwise deal with all or any

properly movable or immovable of trust and use the proceeds thereof for the furtherance of the objects of the trust.

General:-

1. As to the investments of funds of the trust shall be in accordance with provisions of section 13(1) (d) read with section 11 (5) of the I.T.Act.
2. The formation of the trust shall be irrevocable.
3. Any amendment to the trust deed will be carried out only with the prior approval of the commissioner of income tax.
4. The benefits of the trust shall be open to all, irrespective of caste, creed, religion or sex. This Trust is created and run with the intention of serving all and especially the Christian minority people and with institutions with minority status as given by the constitution of India.
5. The income and fund of the trust will solely be utilized towards the objects and no portion of it will be utilized for payment to the trustees.
6. In the event of dissolution / winding up of the trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees but the same shall be transferred to another charitable trust / society whose objects are similar to those of this trust and which enjoy recognition under section 80G of the income tax act.
7. The objects / activities shall be carried out only in India.
8. Any amendments or powers of the trust deed have been given to the trustees, should not extend the basic character / objects of the trust. And further no such amendments which may prove to be

repugnant to the provisions of sections 2(15), 11, 12 & 13 and 80G of the I.T.Act, shall be made.

9. The trust will not function in the nature of condition of a business activity and not for the purpose of profits.

10. The rules and regulations contained in this trust deed may be altered, added or deleted by resolutions passed in the board of trustees, but the same shall not be contrary to the provisions of the Indian Trusts Act and Rules made there under.

11. If any matter of details is omitted which needs inclusion in this deed, the provision of the India Trust Act 1882 shall apply to the same.

At present there is no immovable or movable property to the trust. It is hereby expressly declared that the trust is irrevocable.

I would like to register this deed at the District Registrar Office at Nagercoil.

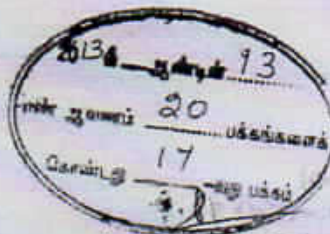

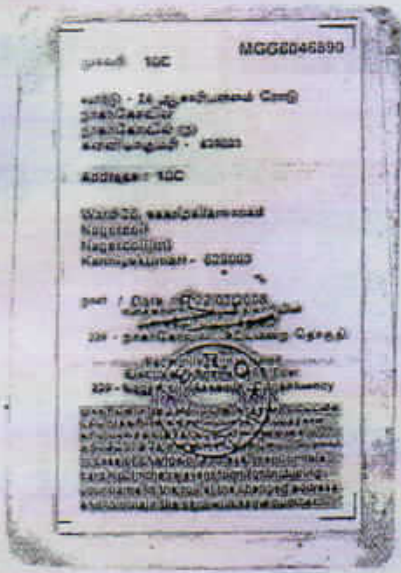

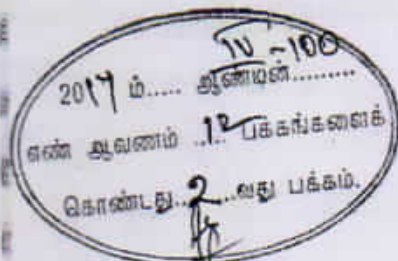

WHEREAS, since bifurcation of the R.C. Diocese of Kottar on December 22, 2014 into R.C. Diocese of Kottar and R.C. Diocese of Kuzhithurai I was appointed the Bishop of R.C.

Diocese of Kuzhithurai by his Holiness Pope Francis and I took canonical possession of the Diocese on February 24, 2015.

WHEREAS, due to the bifurcation of the Diocese of Kottar based on the territorial division, the trust has come under the administrative jurisdiction of R.C. Diocese of Kuzhithurai. Consequently I become the Managing Trustee of the trust by virtue of my Office.
